### SPORTS INTEGRITY POLICY

### 1. SCOPE OF THE POLICY

This policy applies to all participants in TTSTAR SERIES competitions and tournaments, including players, coaches, referees, tournament staff and all other persons with access to privileged information.

### 2. SPORTS BETTING

Contest participants are strictly prohibited from:

- Engage in any betting activity related to TTSTAR SERIES events
- Instruct, permit, or enable others to engage in such activities

This prohibition includes all forms of sports betting - in brick-and-mortar branches, online and in any other way.

### 3. EVENT HANDLING

Contest participants may not:

- Offer, accept or obtain bribes, gifts or other benefits affecting the course or outcome of TTSTAR SERIES events and matches
- Influence, manipulate, or attempt to create such a behavior
- Asking or instructing other persons to do so



## SPORTS INTEGRITY POLICY

### 4. INTERNAL INFORMATION

It is prohibited to request or disclose non-public information that could provide an advantage in betting activities to persons without a legitimate need to know such information.

### **5. DUTY TO REPORT**

Contestants must immediately report suspected violations of this policy to TTSTAR SERIES management or officials. Retaliation against individuals who report violations in good faith is prohibited.

### 6. DUTY TO COOPERATE

Contestants are required to actively cooperate with any investigation of a violation of this policy.

### 7. MONITORING AND ENFORCEMENT

TTSTAR SERIES works closely with Tipsport to monitor betting activities. Suspicious activities will be thoroughly investigated.

### 8. TRAINING

TTSTAR SERIES provides regular sports integrity training to ensure understanding and adherence to this policy.

### 9. CONTRACTUAL ARRANGEMENTS

All contestants sign a contract agreeing to abide by this policy. Violations may lead to disciplinary action including exclusion from competitions.

### 10. COOPERATION WITH THE INTEGRITY PROVIDER

TTSTAR SERIES has an integrity agreement with Tipsport including betting monitoring, data analysis, and investigation support.



### STANDARD OPERATING PROCEDURE FOR ESCALATION

### 1. RECIEVING REPORT

TTSTAR SERIES accepts reports of policy violations from various sources (Tipsport, competition participants, bookmakers, etc.).

### 2. PRIORITIZATION OF RESOURCES

Most trusted sources:

- a) Betting patterns and monitoring (Tipsport)
- b) Direct reports from betting offices
- c) Competition participants / whistleblowers
- d) Course of the competition/match

### 3. PROCEDURE ACCORDING TO THE TIMING OF THE REPORT

- a) Before the events: At the credible threat, TTSTAR SERIES will consider informing participants and possibly postponing/cancelling the event.
- b) During events: If safety is not compromised, the event is completed before proceeding further.
- c) After the events: Credible reports lead to a thorough investigation in cooperation with Tipsport.

TTSTAR SERIES reserves the right to inform the relevant authorities in case of serious criminal consequences.
